

**Brief Note**

The proposal of M/s. Axiom Chemicals Pvt Ltd., is for setting up a new unit in the Dahej-SEZ. They have import of Rs. 17500000.00 capital goods for the proposed project. FOB value of exports for the 5 years period is projected as Rs. 17730.00 Lakhs with NFE of Rs. 7801.2 Lakhs (44 %). The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 36,000 Sq. Mtrs. in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

The proposal is eligible for approval under A/A route. We may therefore if approved, place the same before the Approval Committee for consideration, after personal interview of the Promoters/Directors. The proposal is recommended for approval in terms of the Rule-18 of the SEZ Rules, 2006.

**Item No. 72.2.01**

**Non-submission of Annual Performance Reports by the SEZ units in Dahej - SEZ**

M/s. Avalon Agro Products Pvt Ltd., & M/s. Unique Techno Associates Pvt Ltd., units in Dahej SEZ did not submit their Annual Performance Reports for the Financial Year 2014-15 & 2015-16 as required under SEZ Rules, 2006. Therefore, the matter for non submission of APR of these units were places before 70<sup>th</sup> Approval Committee Meeting held on 04.10.2016 to consider to take action against these units as per SEZ Rules, 2006.

The 70<sup>th</sup> UAC directed to the Specified officer, Dahej SEZ to pursue the units to submit their APRs to the DC office, Dahej SEZ and decided to give one more opportunity to these units to submit their APRs with explanations of delay before taking action under SEZ Rules, 2006 by Development Commissioner, Dahej SEZ.

The unit have not submitted their APRs so far to this office. In view of the above facts, the matter for non submission of APRs by these units of Dahej SEZ is again placed before the Approval Committee to consider to take action under SEZ Rules, 2006 by Development Commissioner, Dahej SEZ.

**Item No. 72.3.01**

**M/s Sigachi Industries Private Limited,-**

Broad-banding of additional item in the existing LOA for trading activity.

M/s Sigachi Industries Private Limited was issued LOA on 19.09.2008, as amended from time to time, for manufacture and export of "Micro Crystalling Cellulose ITC(HS) Code 39123100 and started commercial production from 30.08.2012.

M/s. Sigachi Industries Pvt. Ltd., Dahej-SEZ, vide their letter dated 14/04/2015 requested for broad-banding of LoA for additional items for manufacturing and trading. The request of the unit was approved in the 61<sup>st</sup> UAC Meeting held on 29/05/2015.

Further M/s. Sigachi Industries Pvt. Ltd., Dahej-SEZ, vide their letter dated 18/03/2016 requested for broad-banding of LoA for additional items for trading and enhancement in production capacity of "Micro Crystalline Cellulose". The request of the unit was approved in the 67<sup>nd</sup> UAC Meeting held on 19/04/2016.

Further the unit vide their letter dated 15.07.2016 requested to grant approval for trading of "Crocarmellose Sodium" in addition to existing trading items. Which were already approved in the 61<sup>st</sup> UAC Meeting held on 29/05/2015 as a manufacturing product .

The case was put in the 69<sup>th</sup> UAC held on 19.08.2016 and the committee after detailed discussion deferred the case for proper clarification from the unit

Now the unit vide their letter dated 28.11.2016 explained that they could not start the manufacture of "Crocarmellose Sodium" due to delay in implementation of project and getting the environmental/pollution control clearances, which will be time taking process to comply the mandatory/statutory requirements and to adhere to norms before commencement of project. Therefore the unit want start trading activity of "Crocarmellose Sodium" as per their application dated 15.07.2016.

The Approval Committee may kindly like to accord approval for the new items sought in their request for trading, in terms of Rule-19(2) of the SEZ Rules, 2006 subject to the normal terms and conditions.

Request for adding the new ITC(HSN) code in the manufacture product of Letter of Approval.

M/s Rallis India Limited was issued LOA on 31.03.2008, as amended from time to time, for manufacture and export of the following products:-

Now, the unit vide letter no. nil dated 18.01.2017 have informed that they have developed various chemicals which are part of the Specialty chemicals/ Intermediates, but cover under the ITC chapter 28 to 30 , 38 & 39. They have also informed that they are in the process of developing a new plant to manufacture the Specialty chemicals/ Intermediates. They have already taken permission from the Gujarat pollution control Board for manufacturing the Specialty chemicals/ Intermediates in various ITC code. Unit has import of Rs.2000 Lakhs capital goods for the proposed new project. FOB value of exports for the 5 years period is projected as Rs. 18090 Lakhs with NFE of Rs.7600 Lakhs (72.44%).

The unit requested for Board banding in their exciting LOA to include the ITC chapter heading in Specialty chemicals from current ITC code 30 & 38 to ITC code 28 to 30 ,38 & 39 and By Products from current ITS code 30 & 38 to ITC code 28 to 30 ,38 & 39 without enhancing their Capacity as per the below table.

Approval of Ro-Ro Jetty in Plot No. Z/94/C in non-processing area allotted to M/s. ISGEC Heavy Engineering Ltd., for dual use purpose.

M/s. Dahej SEZ Ltd., requests vide their letter no. DSL/Port/Non-Processing/ISGEC/1469/2017/1926 dated 18.01.2017 to consider ISGEC request for the dual use of Ro-Ro Jetty in Plot No.Z/94/C in non-processing area (Port Area) allotted by Developer to M/s. ISGEC Heavy Engineering Ltd.,

**DSL mentioned that**

1. DSL was granted the permission for Development of Port facilities as authorized operation vide letter dated 05.04.2011 by Board of Approval, MoCI, GoI.
2. Gujarat Maritime Board, Govt. of Gujarat has issued In-Principal approval to M/s. ISGEC for allotment of waterfront vide letter dated 21.11.2013 in front of non-processing area at Plot No. Z/94 of Dahej SEZ.
3. DSL allotted land to M/s. ISGEC on rent basis in Non Processing area (Port area) for Jetty Purpose and the allotment was made by DSL to M/s. ISGEC as Agent/Operator.
4. Gujarat Maritime Board (GMB) dated 30.09.2015 granted permission to M/s. ISGEC Heavy Engineering Ltd., construction of Ro-Ro Jetty in front of Plot No. Z/94 in Dahej SEZ, Bharuch.
5. M/s. ISGEC has made investment of about Rs. 6.30 Cr., in plot no. Z/94/C in non-processing area (port area) at Dahej SEZ.



6. M/s. ISGEC has also completed the work of Jetty/Port (RCC Jetty, Transition slab, Approach- A, Approach- B) in plot no. Z/94/C. (Copy enclosed).

The proposal for develop port facilities in the non-processing area of 15.86 hectares in Dahej SEZ was recommended by Development Commissioner, Dahej SEZ on 28.02.2011 to Board of Approval. The above said proposal was approved by the Board of Approval its meeting held on 25.03.2011.

Gujarat Maritime Board had granted permission to M/s ISGEC Heavy Engineering Ltd vide their letter No.GMB/N/PVT-1/1387/291 dated 30/09/2015 to construction of Ro-Ro Jetty with certain conditions including tri-partite agreement before commencement of cargo operation, Environment CRD clearance, Ownership of the structures shall vest with the GMB, the proposed facilities will be allowed only for handling of captive cargo only. No permission for handling of commercial cargo will be granted by GMB. Proposed anchorage area duly approved by Naval Hydrographic Office, Dehradun. (copy enclosed).

As per the GMB permission at point No.11 "the proposed facility will be allowed only for handling of captive cargo only. No permission for handling of commercial cargo will be granted by GMB.

The Approval Committee may kindly like to accord approve the proposal of Developer, DSL as per SEZ Rules & Act & acceptance of terms and conditions Gujarat Maritime Board (GMB) by the Developer & Unit.

M/s. Sajjan Specialty Limited vide their letter no. SSL/L-136/16-17 dated 10.01.2017 requested to Final Exit/Cancellation/Surrender of Letter of Approval no. Dahej-SEZ/II/6/2010-11 dated 09.11.2010.

The case was placed before the 71st Approval Committee Meeting held on 29.11.2016. The Developer has issued no dues certificate vide letter dated 23.11.2016 & the Specified Officer, Dahej SEZ has also issued no dues vide their letter dated 06.01.2017. LoA holder had not commenced production in SEZ, thus monitoring of NFE does not arise in this case.
