1. M/S. DAHEJ SEZ LTD.

M/S. DAHEJ SEZ LTD. vide their letter no. DSL/09–10/1152 dated 04.11.2009 has submitted the Half yearly Material Utilization Report as on 30th September, 2009 for the Half year April 2009 to September 2009 duly certified by the Chartered Engineer and also submitted the Quarterly Progress Report of Dahej SEZ Ltd. for the quarter July 2009 to September 2009 vide their letter no. DSL/09–10/1154 dated 04.11.2009. The same is placed before the Approval committee for review in terms of provisions of Rule 12 (7) & Rule 22 (4) of SEZ Rules , 2006

2. M/S. BENZO CHEM INDUSTRIES PVT. LTD.

M/S. BENZO CHEM INDUSTRIES PVT. LTD. has earlier applied for the said project on 06.02.2008. The Commissioner, Central Excise & Customs, Vadodara-II vide his letter F.No.IV/16-14/T/SEZ/08 dated 21.11.2008 has informed that Central Excise, Nashik Commissionerate had filed a Regular Criminal Complaint No.415 of 2004 (At present 300415 of 2004) against M/s. Benzo Chem Industries Pvt. Ltd. before the Chief Judicial Magistrate at Jalgaon, Maharashtra. There is another case against M/s. Benzo Chem Industries Pvt. Ltd. alleging violation of Customs Act also.

Further, M/s. Benzo Chem Industries Pvt. Ltd. had not disclosed / declared regarding the above facts / statements in their application. On the basis of this, their application was rejected under Rule-18 of the SEZ Rules, 2006 by this office vide letter dated 01.12.2008 on the ground of suppression of facts and statements. The applicant has not mentioned regarding the said facts in their fresh application dated 20.06.2009 also. The said regular criminal complaint No.415 of 2004 (At present 300415 of 2004) is still pending and the status is confirmed on the official website of District Courts, Maharashtra.
