CASE NO. B-01

1. M/S. TORRENT ENERGY LIMITED

M/s. Torrent Energy LTD. has submitted the List of authorized operations (**Annexure-III**) for the Approval of U.A.C. The matter has been deferred in last meeting of the UAC because of some amendments required in the material list

M/s.Torrent Energy Limited has re-submitted the list after necessary amendments, which is again put up for consideration by the Approval Committee.

CASE NO. B-02

2. M/S. MEGHMANI CHEMTECH LTD.

A Show Cause Notice was given to M/s. Meghmani Chemtech Ltd. vide letter No.KASEZ/DCO/03-MOL/08-09 dated 15.07.2009 for not declaring the details pertaining to the cases of contravention of Customs Act, 1962, Central Excise Act, 1944 which was required to have been disclosed in the application in Form-F submitted by them for setting up their unit in Dahej SEZ.

The unit has replied the SCN vide their letter dated 26.08.2009. The unit stated that it was typological error. They stated that all the pending cases against them are of issues involving interpretation of provision and are not on account of any fraud, collusion or mis-statement with intent to evade payment of duty by the unit except three cases.

A personal hearing was conducted in the matter on 30.03.2010 at 11:30 Hrs. in the Development Commissioner's office. The matter was discussed in the last UAC meeting held on 16.04.2010.

As further discussion is required in the matter, the case is put up once again for consideration by the Approval Committee.

CASE NO. B-03

3. M/S. DAHEJ HOSPITALITY LTD.

M/s.Dahej Hospitality Ltd. has submitted list of goods for the approval of the UAC. M/s.Dahej Hospitality Ltd. has also submitted list of services for approval of the same with a view to claim to refund service tax of the same (**Annexure IV**). Out of 52 services requested, 8 services are not covered under Default Services. These services are:

M/s.Fermenta Biotech Ltd. has further applied (**Annexure-V**) for permission for Phase-II in Dahej SEZ. The items of the manufacture in Phase-II is Pen G Amidase Biocatalysts with positive NFE of Rs.15501 lacs in the period of 5 years.

5. M/S. DAHEJ SEZ LTD.

M/S. DAHEJ SEZ LTD. (The Developer) has submitted the List of goods vide letter No.DSL/10-11/260 (**Annexure-VI**) for the Approval of U.A.C. for their Authorized Operations. The Developer has also submitted the quarterly progress report of Dahej SEZ Ltd. from January, 2010 to March, 2010 (**Annexure-VII**); Half yearly progress report for the half year October, 2009 to March, 2010 (**Annexure-VIII**) and Half yearly material utilization report as on 31st March, 2010 from October, 2009 to March, 2010 (**Annexure-IX**).

CASE NO. B-06

6. M/S. SAJJAN SPECIALTY LTD.

M/s.Sajjan Specialty Ltd. has awarded an LOA on 25.05.2007. Thereafter the LOA has been renewed upto 24.05.2010 by the Development Commissioner, Dahej SEZ under Rule 19(4) of the SEZ Rules, 2006. The unit has sought further extension upto January, 2012 (Annexure-X).

As per the provisions of the Rule 19(4) of the SEZ Rules, 2006 maximum extension is already given to the unit i.e. two years over and above the initial period of one year from the date of LOA.
