DEFERRED CASES :-

CASE NO. B – 01

1. M/s. Shiva Pharmachem Pvt. Ltd.

The case of M/s.Shiva Pharmachem Pvt. Ltd. was deferred from last two UAC(21st & 22nd) meetings. As advised M/s.Shiva Pharmachem Pvt. Ltd. has paid the penalty amount to Central Excise Department under protest. Now the case is again put up as a fresh case.

CASE NO. B - 02

2. M/s.Saraswati Industries Syndicate Ltd.

The case of M/s.Saraswati Industries Syndicate Ltd. was deferred from last UAC meeting. As directed in the meeting, M/s.Saraswati Industries Syndicate Ltd. has submitted detailed case wise list of the pending cases against them (**Annexure-V**). Now the case is again put up as a fresh case.

CASE NO. B - 03

3. M/s.Torrent Energy Ltd.

The case of M/s.Torrent Energy Limited was deferred in the 20th Meeting and also in the last meeting of the Unit Approval Committee.

M/s.Torrent Energy Limited possesses two LOAs – one for as a unit and the other is as a co-developer in Dahej SEZ. As a unit the company generates the electricity and as a co-developer the company will work for creating necessary transmission and distribution network of electricity and carry out electricity distribution in Dahej SEZ area.

Earlier in the LOA, as a unit M/s.Torrent Energy Limited was permitted for generation as well as transmission and distribution of the electricity. Shri Khandelwal, VP-Finance of M/s.Torrent Energy Ltd. stated that LOA issued to unit may be amended to include only generation of electricity. Transmission and distribution may be deleted. The issue was discussed by the members in the 20th meeting and it was decided that before amending the LOA M/s.Torrent Energy Limited has to calculate all the duty details of all materials on which exemption was availed by them as a unit for distribution and transmission of electricity. Shri Khandelwal accepted the same and said that the details will be provided very soon.

Accordingly, M/s.Torrent Energy Limited has prepared the report on calculation of duty vide letter dated 04.09.2010 (**Annexure – VI**) which is put up for consideration by the UAC.

OTHER CASES :-

CASE NO. C - 01

1. M/s.Meghmani Chemtech Ltd.

M/s.Meghmani Chemtech Ltd. vide their Letter dated 11.08.2010 (Copy enclosed – **Annexure – VII**) has submitted a list of Taxable Services for approval of the same with a view to claim to refund service tax of the same.

CASE NO. C - 02

2. M/s.ONGC Petro Additions Ltd.

M/s.ONGC Petro Additions Ltd. vide their letter dated 04.07.2010 requested to issue a certificate mentioning that the services provided by their contractor M/s.EIL are consumed with the SEZ by M/s.OPAL and they are eligible for service tax exemption (**Annexure-VIII**).

CASE NO. C - 03

3. M/s.Chemorge (Jain)

M/s.Chemorge (Jain) vide their letter dated 08.09.2010 requested to transfer the name of ownership i.e. M/s.Chemorge (Jain) to M/s.Glomet Technologies Pvt. Ltd. (**Annexure-IX**).

CASE NO. C – 04

4. M/s.Sarju Impex Limited.

M/s. Sarju Impex Limited vide their letter No.SIL/KASEZ/2010-11/016 dated 14.09.2010 requested for broad banding. They requested that as a part of manufacturing process, they need Oxygen gas for free forming and cutting machines of their raw material. Due to heavy transportation problem it is not viable to purchase the Oxygen gas. So they proposed to set up Oxygen manufacturing process in their plant itself with increased capital investment of Rs.90.00 Lacs for air separation plant. They also intend to sell the excess part of Oxygen and it's by product Nitrogen gas in domestic market nearby Dahej.
