#### 41.5.1 M/S. CHEMETALL LITHIUM INDIA PVT. LTD.

M/s. Chemetall Lithium India Pvt. Ltd. vide letter dated 01.05.2012 submitted that the company have been changed from M/s.Chemetall Lithium India Pvt. Ltd. to M/s. Rockwood Lithium India Pvt. Ltd.

The unit submitted that M/s.Chemetall Lithium India Pvt. Ltd. (Chemetall) is a wholly owned subsidiary of Chemetall GmbH, Germany. Chemetall GmbH is a part of Rockwood Holding Inc. (NYSE:ROC).
