43.5.1 M/S.OIL AND NATURAL GAS CORPORATION LTD.(ONGC)

Dakshin Gujarat Vij Company Limited(DGVCL) to become Service Provider for power supply in Dahej SEZ in view of request from ONGC to allow construction of transmission/distribution lines by Gujarat Energy Transmission Corporation Ltd.(GETCO).

DGVCL vide letter dated 04.08.2012 submitted that they are an existing licensee in the Dakshin Gujarat area for distribution of Electricity which includes the SEZ area of Dahej. By being a licensee DGVCL is entitled to lay down electricity distribution network and effect supplies to consumers. DGVCL further submitted that they are entitled to lay down lines in Dahej SEZ area without any further need to take any approval or permission from the Co-Developer or Developer.

DSL vide letter dated 08.08.2012 submitted that they have no objection for distribution of power by DGVCL to SEZ units in Dahej SEZ area as GERC granted permission to DGVCL for distribution of power in Dahej SEZ area. But DGVCL has to become Service Provider in addition to Torrent Energy Ltd.(TEL), being Co-Developer for distribution of power to SEZ units.

ONGC vide letters dated 18.10.2012 submitted that, in 2008, when their plant was constructed, power supply to the plant was provided by DGVCL at 220 kv. As per safety point of view and also as an industry practice, two independent sources of power are essential for such plants. As per prevailing acts & regulations both incoming feeders are required from same company, which is DGVCL here.

As per Section 53 of SEZ Act, 2005, Special Economic Zone shall, on and from the appointed day, be deemed to be a territory outside the Customs territory of India for the purpose of undertaking the authorized operations. Thus, to undertake any authorized operations in SEZ, approval has to be obtained from Board of Approval or Unit Approval Committee as the case may be.
