#### **Brief Note**

The proposal of M/S Desai Polymers., is for setting up a new unit in the Dahej-SEZ. They have import of Rs. 6000.00 Lacs capital goods for the proposed project. FOB value of exports for the 5 years period is projected as Rs. 110000.00 Lakhs with NFE of Rs. 95000.00 Lakhs (86.36 %). The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 80,000 Sq. Mtrs. in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

The proposal is eligible for approval under A/A route. We may therefore if approved, place the same before the Approval Committee for consideration, after personal interview of the Promoters/Directors. The proposal is recommended for approval in terms of the Rule-18 of the SEZ Rules, 2006.

<u>Item No. 70.2</u> <u>Deferred cases for Dahej -SEZ:-</u>

<u>Item No. 70.2.01</u> <u>M/s Torrent Pharmaceuticals Limited .</u>

Request for HDFC Bank ATM facility in Company premises, SEZ Dahej.

The request of M/s Torrent Pharmaceuticals Limited (M/s TPL) was placed before 69th UAC of Dahej SEZ but none of the promoter/director or any authorized representative of the unit appeared before the Approval Committee to explain their request. The Approval Committee after detailed discussion asked the Developer, Dahej SEZ Ltd to study the feasibility of opening ATM of HDFC Bank for the benefit of all employees of units in Dahej SEZ Part –II area and appraise the office of Development Commissioner / Unit Approval Committee.

Now, M/s TPL has again submitted request vide their letter dated 21.09.2016 for HDFC Bank ATM facility in Company premises, Dahej SEZ and emphasized to place their request in next UAC for consideration.

In view of the above, the matter is placed before the Approval Committee of Dahej SEZ to consider under SEZ Act, 2005 & SEZ Rule, 2006.

<u>Item No. 70.3</u> <u>Other cases for Dahej -SEZ</u>:-

<u>Item No. 70.3.01</u> <u>M/s Britannia Industries Limited .</u> Surrender of Letter of Approval

M/s. Britannia Industries Limited were approved a unit in Dahej SEZ vide LOA dated 11/03/2016 for setting-up of new unit. They have now requested vide their letter dated 08/09/2016 for Surrender of LOA No. DAHEJ-SEZ/II/006/2015-16/1316 dated 11/03/2016. The unit has cited reasons of environmental factors and other chemical industries in Dahej SEZ which may be harmful to the food proposed food products. The Approval Committee may kindly like to accord approval for the said request.

# <u>Item No. 70.3.02</u> <u>Non-submission of Annual Performance Reports by the SEZ units in Dahej - SEZ</u>

The Approval Committee had granted approvals for 78 entrepreneurs/units in Multi Sector, Dahej SEZ. Out of which 35 units have started their commercial operation as on 31-03-2015. In terms of provisions of Rule 22 of the SEZ Rules, 2006, the units are required to submit their Annual Performance Reports within a period of ninety days following the close of financial year in prescribed proforma i.e. Form I, duly certified by a Chartered Accountant to the Development Commissioner and the Development Commissioner shall place the same before the Approval Committee for consideration.

The following units of SEZ, Dahej have not submitted their Annual Performance Reports for last two years from the date of commencement of production.

# <u>Item No. 70.3.03</u> <u>Lapse of Letter of Approval after expiry of validity period of Dahej SEZ units</u>

#### Rule 19(4) &(5) of SEZ Rules, 2006

The Letter of Approval shall be valid for one year within which period the Unit shall commence production or service or trading or Free Trade and Warehousing activity and the Unit shall intimate date of commencement of production or activity to Development Commissioner:

Provided further that the Development Commissioner may grant further extension of one year subject to the condition that two-thirds of activities including construction, relating to the setting up of the Unit is complete and chartered engineer's certificate to this effect is submitted by the entrepreneur:

If the unit has not commenced production or service activity within the validity period or the extended validity period under sub-rule (4), the Letter of Approval shall be deemed to have been lapsed with effect from the date on which its validity expired.

The validity date of Letter of Approval of the following units has been lapsed and they have not submitted a request in writing to Development Commissioner, Dahej SEZ.

As the above units have neither intimated commencement of production nor requested for extension of Letter of Approval within stipulated time as required under SEZ Rules, 2006, the Approval Committee may kindly consider to take action against these units as per SEZ Rules, 2006.

# Item No. 70.3.04. Approval of list of services in respect of units in Dahej - SEZ.

In terms Section-26 of the SEZ Act, 2005, read with Rule-31 of the SEZ Rules, 2006; quote "Exemption from service tax:- The exemption from payment of service tax on taxable services under section-65 of the finance Act, 1994 (32 of 1994) rendered to a Developer or a Unit (including a Unit under construction) by any service provider shall be available for the authorized operations in a Special Economic Zone" unquote.

Under the above SEZ provisions a Developer or a Unit was exempted from payment of Service Tax on taxable services. However, the Government of India, in the Ministry of Finance, had amended the aforesaid provision vide CBEC Notification No. 9/2009-Service Tax, dated 03-03-2009, as amended from time-to-time, wherein the developer or units of SEZ shall have to get the list of services approved from the Approval Committee, as specified services, for the required exemption, etc.

The Department of Commerce, in view of bringing uniformity, in the list of taxable services applicable for all SEZs in India, devised a default list of 66 (sixty-six) services. These 66 services were approved as default services in the 55th Approval Committee for Dahej – SEZ held on 27-08-2014. Now, the following SEZ units have sought approval/permission for new additional taxable services, as under:-
