65.2 Defer cases for Dahej –SEZ:-

Item No. 65.2.1. M/s Gujarat Alkalies and Chemicals Limited – Request for permission for transportation of HDPE pipes and accessories to work at offshore segment in the Sea through SEZ Road from entry gate for area to Light House.

M/s Gujarat Alkalies and Chemicals Limited vide their letter no. GACL/DHJ/Civil/15-16 dated 08/09/2015 has requested for permission for transportation of HDPE pipelines, RCC ballast block, MS-HDG vertebra armours, lateral anchoring assemblies, welding machine, workmen, GACL/Contractors, tractor with trolleys, car/jeep, construction equipments etc. for the period of 10 months i.e. 02.09.2015 to 30.06.2016 to work at offshore segment in the Sea through non-processing area SEZ Road from entry gate Port area to Light House. They informed that this is the only area available for initiating the work in I/T & Offshore segment area. They have also obtained NOC from Dahej SEZ Ltd. for using SEZ road from entry gate port area to light house.

The case was put-up before the 64th meeting of Approval Committee held on 12-10-2015, wherein none of the promoter/director or any authorized representative appeared before the Committee to explain their proposed proposal in SEZ. The Committee decided to defer the case for the next meeting and call the detailed report from the Specified Officer, Dahej SEZ.

Now, M/s. Gujarat Alkalies and Chemicals Limited vide their letter No. GACL/DHJ/Civil/15-16 dated 30/10/2015 submitted undertaking that in case of any damage will be made to the road or DSL premises or SEZ premises during transportation or their operation; the same will be repaired/rectified and brought to the original condition by them at their cost. The Approval Committee may kindly consider the approval for the same.

65.3 Other cases for Dahej –SEZ:-

Item No. 65.3.1. M/s Tatva Chintan Pharma Chem Pvt. Ltd. – Request for change in Area by Plot Addition 31720.81 sq. mtrs. At Dahej SEZ

M/s Tatva Chintan Pharma Chem Pvt. Ltd. were approved vide LOA dated 22-05-2011 for setting up of new unit in Dahej-SEZ. They were issued offer-cum-allotment letter for plot No. Z/103/F/1 of 20098.45 sq.mts.(Tentative) area. They have now requested vide their letter no. Nil dated 23/10/2015 for change in Area by Plot addition 31720.81 sq.mtrs. (plot No.Z/103/F/2) at Dahej SEZ. They have also got letter dated 03/10/2015 from M/s. Dahej SEZ Ltd for allotment of plot no. Z/103/F/2 and lease deed has been made between them on 17/10/2015. The Approval Committee may kindly consider the approval for the said request.

Item No. 65.3.2. M/s Tatva Chintan Pharma Chem Pvt. Ltd.
Request for Broad-banding of LOA.

M/s Tatva Chintan Pharma Chem Pvt. Ltd. were granted approval for setting-up of new unit in Dahej-SEZ, vide LOA dated 22-05-2011 and extension of the validity of LoP up to 22nd May, 2016 is also approved.

They have now requested for broad-banding of LOA for inclusion of two new products and enhancement of one product capacity and reducing capacity of the one product following their existing products into LOA. The details are as under:

Since they have not commenced commercial production in the SEZ, the case is placed before the Approval Committee for consideration to broadband the LOA, in terms of Rule-19(2) of the SEZ Rules, 2006 subject to the normal terms and conditions.

Item No. 65.3.3. M/s ONGC Petro additions Limited (OPaL)
Request for broad-banding of LOA for Revision/Addition of items to the LOA.

M/s ONGC Petro additions Limited were issued LOA on 16-10-2007 for Manufacture and export of (1) High Density Polyethylene (HDPE)-300000 MT (2) Linear Low Density Polyethylene (LLDPE) -720000 MT (3) Poly-propylene (PP)-340000 MT (4) Styrene Butadienf Rubber (SBR) -140000 MT (5) Styrene -160000 MT (6) Hydrogenated Pyrolysis Gasoline (HPG) - 135000 MT (7)Carbon Black Feed Stock (CBFS) per Annual Capacity.

Now, the Unit, vide their application dated 28/11/2015 have requested to revise the product list of OPaL with the revision of products (1) Ethylene -1100000 MT

(2) Propylene -400000 MT (3) HDPE (Dedicated)-340000 MT (4) LLDPE/HDPE (Swing)-720000 MT (5) Polypropylene - 340000 MT (6) Hydrogenated PyGas 164000 MT (7) CBFS 75000 MT (8) Hydrogen- 63000 MT (9) Fuel Gas 405000 MT (10) Butene-I - 35000 MT (11) Butadiene-115000 MT (12) Benzene-150000 MT (13) Styrene-95000 MT (14) Sktyrene Butadiene Rubber-160000 MT (15) C9 + fraction - 32400 MT (16) Low Polymer Wax Dedicated HDPE- 8211 MT (17) C6+ - 2930.4 MT per Annual Capacity. They have stated that Ministry of Environment, Forest and Climate Change (MoEF) vide its letter dated 30/09/2015 has revised the optimized products list of OPaL.

As the unit has started working in SEZ Dahej, the Approval Committee may kindly like to consider approval for the broad-banding in the items of manufacture to the LOA in terms of Rule- 19(2) of the SEZ Rule, 2006.

Item No. 65.3.4. M/s Palvi Power Tech Sales Pvt. Ltd.
Request to add activity of Trading (Export of Goods) in Broad Band approval.

M/s Palvi Power Tech Sales Pvt. Ltd. was issued LOA on 06/02/2013, as amended from time to time, for manufacture and export of Molybdenum Chemicals. They had commenced commercial production w.e.f. 22/05/2015 and started exporting goods and they are hopeful to achieve the NEF within prescribed time limit.

Now the Unit, vide their application dated 09/10/2015 have requested to add the list of items as proposed in Annexure I & II under trading activity with their existing products. As the unit is working and exporting from the SEZ, the Approval Committee may kindly like to consider approval for the Trading Permission in terms of Rule- 19(2) of the SEZ Rule, 2006.

Item No. 65.3.5. M/s Gujarat Industrial Development Corporation
Request for permission for allocation of 5.00 mt wide corridor through SEZ Area for the proposed drainage pump main from 40 MLD CETP to be constructed at Dahej PCPIR.

M/s. Gujarat Industrial Development Corporation vide their letter no. GIDC/SE(CG)/Bharuch/3345 dated 18/11/2015 has requested for permission for allocation of 5.00 mt wide corridor through SEZ Area for the proposed drainage pump main from 40 MLD CETP to be constructed at Dahej PCPIR for carrying treated effluent from CETP is planned to take up to Ambheta Drainage Final Pumping station from where it will be discharged into deep sea.

They have also obtained principle approval from Dahej SEZ Ltd. for using corridor of SEZ for the proposed drainage line. In past similar type of requests were referred to BoA for consideration and approval as the same is not in its competency. The case is placed before the Approval Committee for consideration.
