52.1 Fresh Cases:-

52.1.1 M/s. Annie Chemie Pvt. Ltd., Vadodara:

Shri Anmol Kamdar, Director of the applicant company appeared before the Approval Committee for interview and put forth the following points:-

- i) The proposal is for manufacture and export of A) Inorganic Chemicals & Excipients; B) Organic Chemicals & Excipients; C) Applied Chemicals & Mixtures; and D) Flavor & Fragrances/Blends;
- ii) Total cost of the project is Rs. 323.00 lakh.
- iii) Total export is projected at Rs. 19500.00 lakh, with outgo of Rs. 6500.00 lakh, resulting in NFE earnings of Rs. 13000.00 lakh in five years period.

The Committee after due deliberation approved the proposed project, subject to the standard terms and conditions of the SEZ Rules, 2006.

52.1 Other Cases for Dahej-SEZ:-

52.2.1 M/s. Meghmani Organics Ltd., Dahej - SEZ:

Shri Manukumar Mori, GM (Comm/Admn), of the applicant company appeared before the Committee, and explained their proposal for amendment/broad-banding of LOA to include by-products ten items viz. 1) Ammonium Sulphate; 2) Dilute/Spent Sulphuric Acid 20%; 3) Copper waste; 4) Copper Sulphate; 5) Gypsum; 6) Dilute Hydrochloric Acid; 7) Sodium Hypochloride; 8) Pattasium Bromide (Kbr solution); 9) Sodium Slurry; and 10) Dilute Ammonium Carbonate, which are generated during the course of manufacturing their approved products. The Committee approved the same, subject to standard terms and conditions of the SEZ Rules, subject to adhering to all mandatory/statutory requirements including that of environment/pollution norms.

52.2.2 M/s. Neobags Overseas Pvt. Ltd., Dahej - SEZ:

Shri Devendra S. Bhat, (Head – Logistics) of the applicant company appeared before the Committee, and explained their request for inclusion of Chapter-63 of the ITC (HS) - 63053200 for the approved product of export i.e. 'FIBC Bags' and have sought amendment in the LOA. The Committee approved the same, subject to standard terms and conditions of the SEZ Rules.

52.2.3 M/s. Prakash Chemicals International Pvt. Ltd., Dahej – SEZ:

Shri Arif Bazi, VP, and Shri Vishwas M. GM of the applicant company appeared before the Committee, and explained their requirement of additional items/products for trading and exports, viz. 1) Ethyl Acetate; 2) Benzyl Chloride; 3) Benzyl Alcohol; 4) Chloro Paraffin; 5) Sodium Hydroxide Flakes/Prills; 6) Poly Aluminum Chloride; 7) Monochloro Acetic Acid; 8) Acetic Acid; 9) Monochloro Acetic Acid; and, 10) Toluene Di-Isocyanate. The

Committee approved the same, subject to standard terms and conditions of the SEZ Rules, 2006, and the trading items shall be for exports only and no DTA sales shall be allowed for the proposed trading items.

52.2.4 M/s. Rockwood Lithium India Ltd., Dahej - SEZ:

Shri Sandeep Murarka, ED of the applicant company appeared before the Committee, and explained their requirement of additional items/products (56 numbers) for trading & exports, for R&D by their Indian customers based in DTA, EOU, & SEZ, to develop the products for manufacturing purpose. Further, with regards to providing of "Technical Services" he informed that the Pharma. Companies buying their above products are regulated by FDA, US and to maintain high standard quality, guidance to use the products/storage/building adequate infrastructure at plant site and technical services from R&D stage to commercial production, their employees at Dahej unit provide the same. For these services provided they will raise bills in foreign currency. The Committee approved both the proposals, subject to standard terms and conditions of the SEZ Rules, 2006. The trading activity is permitted initially for a period of one year.

52.2.5 M/s. Torrent Energy Ltd., Dahej – SEZ:

Shri Nilesh Khatri, General Manager, of the Co-Developer/applicant Company explained the requirement of additional items for default Authorized Operations in the SEZ, as per their request letters dated 23-11-2013, 20-12-2013, 09-01-2014 and 24-01-2014. The Committee approved procurement of duty-free goods for the default Authorized Operations, subject to standard terms and conditions of the SEZ Rules, 2006.

52.2.6 Approval of list of service in respect of Developers and units in Dahej-SEZ:

The Chairman informed the Committee that the default list of 60 (sixty) services has been issued by Kandla – SEZ for all SEZs in Gujarat in order to bring uniformity. However, for any addition of new services the Approval Committee can decide on case-to case basis on merits, and was of the opinion that the current proposal needs analysis on case-to-case, with proper justification of each such service required and sought in the SEZ. The matter needs to be discussed and examined at length and if required the Commissioner of Service Tax may be called for the next meeting. Thus, the current proposal was deferred for decision in the next meeting.
