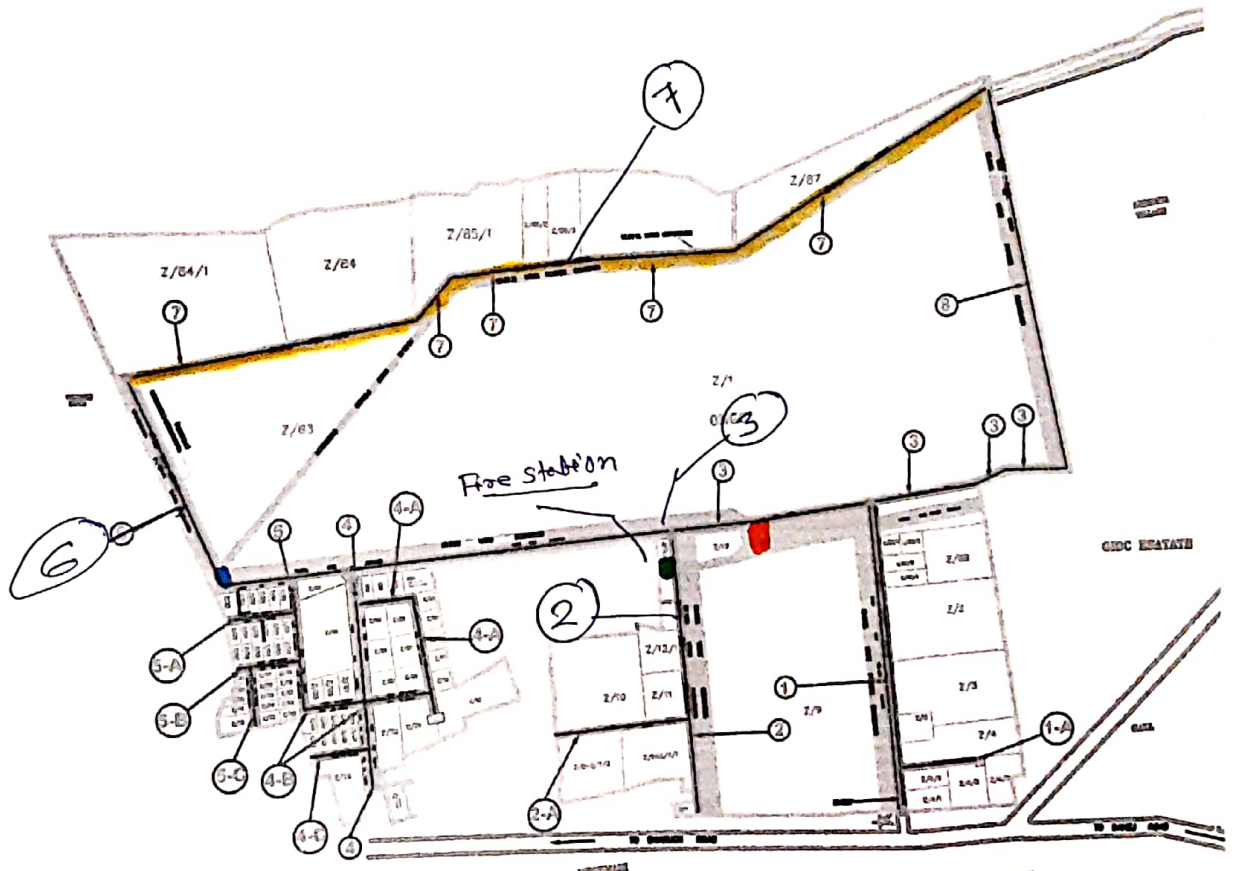

SCOPE OF WORK:

- If required, Contactor has to make temporary/permanent approach for the work for which no payment shall be paid by Dahej SEZ Ltd. (DSL).
- Cutting of jungles/bushes/wild trees/shrubs etc. and disposed off / dump as per instruction of Engineer –in-charge/DSL within SEZ /outside SEZ area. For outside SEZ area, contractor is responsible to identify the area.For this activity no any additional payment made by DSL.
- Wherever it is not possible to clean the area mechanically the work shall be carried out manually without any extra cost/charge.
- Scope includes Cutting, filling, spreading of existing soil and leveling is to be done as per instruction of Engineer –in-charge.
- Contractor has to stack the useable materials as directed by Engineer-in-charge.
- Contractor has to take care for existing underground /overhead services in corridor area. If damage occurred then damage cost will be recovered from contractor.
