Introduction:

Sealed tenders are invited from eligible agency / firm for supply of Tanker Water Supply for watering of plantation / gardening area of Dahej SEZ, at Dahej.

Scope of work and Terms and Conditions:

- 1. The Water Tanker to be supplied shall be use for watering of plantation / gardening with transportation, drivers, operators, pumps, pipelines etc. so as to reach water at interior / last plant planted.
- 2. The supply of water tanker to Dahej SEZ Ltd, Dahej will be on actual requirement basis only.
- 3. The agency shall have to pump / lift / spared the water with proper pipelines / pump to plantation planted by DSL without damaging the DSL plantation work.
- 4. The tanker tank capacity must be at least 24,000 Ltr.
- 5. The Bill for supply of tanker will be raised on monthly basis by the agency to Dahej SEZ Ltd. supported with invoices, GPS report, statement of gate pass etc., and duly certified by authorized representative of Dahej SEZ Ltd.
- 6. Water tanker shall have to be supplied on urgent basis on short notice, as and when required, within two hours of receiving the telephonic order.
- 7. Tanker shall be filled properly to the full capacity of tank. The acknowledgement of trips shall be signed duly by the contractor and hand over to departmental / security at receipt point located at various storage tanks. Original delivery Challan shall be handed over to the departmental representative.

- 8. The agency shall ensure that valid working GPS system is installed before commencement of supply of vehicles to DSL. The report of GPS generated through system is to be submitted (duly certified by agency) to DSL along with bill / invoice, failing which payment will not be processed. DSL shall have right to check live status / location of vehicle at any time during supply.
- 9. Agency shall supply vehicle with drivers and operators. The mobiles phones shall be provided to them by agency. In case change of drivers / operators, it will be intimated to DSL immediately in written with ID card.
- 10. The agency shall adhere to the safety, health, traffic norms as applicable in Dahej SEZ.
- 11. In case of delay in supply of water tanker , penalty @ Rs.1500/- per hour will be charge or DSL will hired the water tanker and payment made by DSL will be deducted from due payment of agency.
- 12. Tank inside & outside shall have to be Epoxy coated and size of the tanker to be displayed on the tanker clearly.
- 13. The rates quoted shall be inclusive of waiting, filling, loading-unloading time. No extra claims shall be entertained on account of above factors. Rate quoted is for supply of water tanker for 8 hrs/ day.
- 14. The rate quoted will be applicable for whole quantity of water mentioned above. In case of less quantity of water found, action as per sr. no. 11 will be taken.
- 15. The supply of tankers should be during the office hours as far as possible and beyond office hours if required.
- 16. The agency shall arrange at its own expense all necessary tools and equipment's required for execution of the work.
- 17. The agency would follow SEZ rules and Regulation.
- 18. Agency would comply with all the other facilities and requirement as per tender and conditions mentioned in work order.
- 19. The agencies / Bidders are expected to examine the tender Documents carefully and are deemed to have read all conditions of tender notice.
- 20. The agency has to submit their price bid / financial including taxes, expenses. No other extra payment would be made by DSL.
- 21. Where water is supplied by DSL, agency shall not misuse it inside or out site Dahej SEZ whatsoever manner. In case any misuse found, the penalty @ 10 times of rate of

per tanker will be charged and shall be deducted from payment / SD. And decision of the DSL shall be final and binding.

22. EARNEST MONEY DEPOSIT (EMD):

An Earnest Money Deposit (EMD) of Rs.5600/-(Rupees five thousand six hundred only) in the form of Demand Draft drawn in favour of Dahej SEZ Limited payable at Gandhinagar is required to be attached with the technical Tender. The EMD is liable to be refunded after conclusion of the tendering process.

No interest shall be accrued on the said security deposit and EMD.

EMD will be forfeited if agency fails to execute the contract as per terms and conditions mentioned in the tender. E.M.D of successful tender shall be adjusted against security deposit.

23. SECURITY DEPOSIT:

- 1. The successful tender shall be required to deposit 10% of contract value as security deposit in the form of Demand Draft drawn in favour of Dahej SEZ Limited payable at Gandhinagar as security deposit at the time of signing of agreement.
- 2. The amount of security deposit is liable to be refunded at the earliest after completion of the contract. In case of termination of contract due to no satisfactory performance by agency, the security deposit will be forfeited.
- 3. No interest shall be accrued on the said security deposit and EMD.

- 5. Agency may terminate the contract by giving 3 month notice to DSL. If agency terminate the contract without giving notice period then all due payment will be forfeited.

- **38**. In case of dispute / clarification / interpretation, the decision of CEO, DSL shall be binding.

39. DISQUALIFICATION CLAUSE:

The Bidder shall be disqualified if:

- (a) The bidder or any of its constituent(s) has been blacklisted/banned business dealing by any Government Department, Government Agency or Public Sector Undertakings at any time, except in cases where such blacklisting / banning has been withdrawn by competent authority or ceased on the deadline for submission of the bid, for which satisfactory evidence is to be produced.
- (b) The bidder or any of its constituents has been issued a show cause notice for poor performance / banning / blacklisting or business or order for suspension of business by the competent authority
