With reference to the above subject, Dahej SEZ LTD (DSL) is hereby issuing In principle approval to M/s. Camlin Fine Sciences Limited (CFSL) for offering land on RoU subject to following conditions:

1. M/s. CFSL has to obtain permission / approval from Development Commissioner, Dahej SEZ BOA, MoCI for laying pipe line in Dahej SEZ area.
2. M/s. CFSL has to execute RoU agreement with DSL before commencement of work at site.
3. Before laying the Pipeline, a trial pit is to be made to know the exact location of existing underground services within SEZ area. M/s. CFSL has to take care for the existing services within SEZ area.
4. M/s. CFSL has to contact concern authority for necessary guidance/information/approval before starting the work at site to avoid any damage. If any damage occurred during execution of works then same shall be attend by M/s. CFSL immediately and cost for the same shall be borne by M/s. CFSL. The damage area shall be restored as per methodology suggested by concern authority/DSL. Any compensation for damage is to be paid by M/s. CFSL.

With reference to the above subject, Dahej SEZ Ltd. (DSL) is here by issuing In principle approval to M/s. Camlin Fine Sciences Limited (CFSL) for offering land on RoU subject to following conditions:

1. M/s. CFSL has to obtain the permission/ approval from Office of The Development Commissioner, Dahej SEZ / BOA, MoCI for laying pipeline in Dahej SEZ area.
2. M/s. CFSL has to submit the approval of GIDC for laying express line of treated effluent & GPCB consent for the same before executing ROU agreement. M/s. CFSL has to follow the terms & conditions mentioned in the letter issued by GIDC & GPCB.
3. M/s. CFSL has to execute ROU agreement with DSL before commencement of work at site.
4. Before laying the Pipeline, a trial pit is to be made to know the exact location of existing underground services within SEZ area. **Trial pit must be done manually only.** M/s. CFSL has to take care for the existing services within SEZ area. If any damage occurred then damage cost will be borne by M/s. CFSL.
5. M/s. CFSL has to contact concern authority for necessary guidance / information / approval before starting the work at site to avoid any damage. If any damage occurred during execution of works then same shall be attend by M/s. CFSL immediately and cost for the same shall be borne by M/s. CFSL The damage area shall be restored as per methodology suggested by concern authority/DSL.
