M/s. Oil and Natural Gas Corporation Limited-C2C3Request for granting permission for laying of 11 KV 3X240SQMM XLPE Power Cable line from Getco 66KV Dahej-A

S/S to M/s ONGC C2-C3 plant.

M/s Oil and Natural Gas Corporation Ltd C2-C3 was issued LOA on 06.03.2007 as amended from time to time, for manufacture and export of 1) Ethane C2, 2) Propane C3, 3) Butane C4, 4) Lean LNG and started commercial production from 17.07.2015.

M/s Oil and Natural Gas Corporation Ltd C2-C3, vide their letter no. NIL dated 26.06.2024 has requested for granting permission for laying of 11 KV 3X240 SQMM XLPE Power Cable line from Getco 66KV Dahej-A S/S to M/s ONGC C2-C3 plant.

M/s Dahej SEZ Limited, Developer of Dahej SEZ vide their letter dated 19.06.2024 issued in principle approval to M/s ONGC C2 C3 for offering land on RoU subject to certain conditions including M/s ONGC C2 C3 has to obtain permission from DC, Dahej SEZ for laying of 11 KV 3X240 SQMM XLPE Power Cable line from Getco 66KV Dahej-A S/S to M/s ONGC C2-C3 plant.

The applicant unit has submitted Route Map for the above said power cable line. The unit vide their email dated 01.08.2024 informed this office that the project was awarded by ONGC through open tendering and the lowest project cost was discovered through competitive bidding, hence the services of Chartered Engineer were not required for evaluation of the project.

The SO, Dahej SEZ vide their email dated 28.08.2024 has informed this office that ONGC C2C3 has availed duty benefits for solar power plant installation.

The case was put up in the 119th UAC Meeting wherein the committee after detailed discussion unanimously deferred the proposal and informed the SO, Dahej SEZ to submit the inspection report.

The unit's vide their email dated 06.09.2024 has stated that prior approval for the setting up of solar power plant at the unit premises was not taken, the solar power plant is around 75% completed and the duty benefit availed is around 1.21 crore. The SO, Dahej SEZ vide letter dated 10.09.2024 has informed that the unit has availed duty benefits amounting to Rs. 1.21 Crores and the solar power plant is nearly 75% installed. SO, Dahej SEZ office has not granted any permission for installation of solar power plant.

The proposal of M/s. ONGC C2C3 for granting permission for laying of 11 KV 3X240 SQMM XLPE Power Cable line from Getco 66KV Dahej-A S/S to M/s ONGC C2-C3 plant is again placed before the Unit Approval Committee Meeting for a suitable decision.

M/s Deepak Chem Tech Limited. Cancellation of Letter of Approval.

M/s Deepak Chem Tech Limited, Vadodara was issued Letter of Approval dated 29.02.2024 for manufacturing items under chapter 27 & 29 of ITC (HS).

The unit vide their letter dated 04.09.2024 has requested for Cancellation of letter of approval and exit from Dahej SEZ. They informed that they had applied for the SEZ land considering feedstock supply options from the OPAL, a SEZ Unit, which was identified as next-door supplier using pipeline connectivity. Additionally, they were also expecting to target international markets for some of the downstream products. However, OPAL is at an advance stage of getting DTA status and growth prospects in international markets are also diminishing. The unit therefore re-evaluating their downstream projects to meet requirements of the Domestic Market, and they believe that this project is not feasible in the SEZ area.

In view of the above, request of M/s Deepak Chem Tech Limited for cancellation of letter of approval from Dahej SEZ is placed before the UAC for a suitable decision.

Dear sir,

As per the letter no DAHEJ-SEZ/II/004/2023-24/6055 dated 29.02.2024, we received a letter of approval regarding establishment of new unit in Dahej Special Economic Zone, Dahej, Dist. Bharuch for undertaking authorized operations from your good office.

We had applied for the SEZ land considering feedstock supply options from the OPaL, a SEZ unit, which was identified as next-door supplier using pipeline connectivity. Additionally, we were also expecting to target international markets for some of the downstream products. However, as we understand, OPaL is at an advanced stage of getting DTA status while growth prospects in international markets are also diminishing. We are therefore re-evaluating our downstream projects to meet requirements of the Domestic market, and we believe that this projects are not feasible in the SEZ area. We will therefore request you to cancel the Latter of Approval earlier issued to us. Looking forward to your consideration and please advise if you need any further information.
