M/s. Omgene Life Sciences Pvt Limited

Non-submission of Lease deed and Acceptance of LoA.

M/s Omgene Life Sciences Pvt Ltd was issued LOA on 21.11.2023 as amended from time to time, for manufacture and export of items under various HS Codes of Chapter 29 of ITC HS Code.

This office has issued a letter of approval to the firm on 21.11.2023. As per conditions of Letter of Approval the unit has to submit the acceptance of LoA to the Development Commissioner Office within forty-five days of issuance of LoA. Till date M/s Omgene Life Sciences Pvt Ltd has not submitted the LoA acceptance to this office and also not submitted the registered lease deed to this office as per requirement of Rule 18 (2)(ii) of SEZ Rules, 2006.

Rule 18(2)(ii) of SEZ Rules, 2006 provides that: -

Provided that the Developer shall enter into a lease agreement and give possession of the space in the Special Economic Zone to the entrepreneur only after the issuance of Letter of Approval by the Development Commissioner:

[Provided further that a copy of the registered Lease Deed shall be furnished to the Development Commissioner concerned within six months from the issuance of the Letter of Approval and failure to do so, the Approval Committee may take action to withdraw the Letter of Approval after giving an opportunity of being heard;]

Omgene Life Science has requested for extension of LoA for one more year and the firm had not submitted the registered lease deed to this office.

The case of M/s. Omgene Life Sciences Pvt Ltd is placed before the Unit Approval Committee Meeting for a suitable decision.

M/s. Neogen Chemicals Limited

Non-submission of Lease deed

M/s Neogen Chemicals Ltd was issued LOA on 16.10.2014 as amended from time to time, for manufacture and export of items under various HS Codes of Chapter 28 and 29 of ITC HS Code.

This office has issued a letter of approval to the firm on 16.10.2014. As per conditions of Letter of Approval the unit has to submit the registered lease deed to the Development Commissioner Office within six months of issuance of LoA. Till date M/s Neogen Chemicals Ltd has not submitted the registered lease deed to this office as per the requirement of Rule 18 (2)(ii) of SEZ Rules, 2006.

This office has renewed the LOA of the firm for one year only as the firm has not submitted the lease deed to this office since the LoA was expiring on 14.10.2024.

The case of M/s. Neogen Chemical Ltd is placed before the Unit Approval Committee Meeting for a suitable decision.

Dahej SEZ Units

Monitoring of SEZ Entities

It has come to the notice of this office that the some of the units are following a lackadaisical approach while submitting the application for Renewal of LoA and also in submitting the APR to this office. Further inspite of repeated letters, the firms are not submitting the reasons for delay in submitting the APR. The SO Dahej SEZ has pointed out several times that the units are not providing the required documents to his office for reconciliation of the data.

Rule 54(2) of the SEZ Rules, 2006 provides that:-

In case the Approval Committee come to the conclusion that a Unit has not achieved positive Net Foreign Exchange Earning, [or stipulated Value Addition as specified in rule 53] or failed to abide by any of the terms and conditions of the Letter of Approval or Bond-cum-Legal Undertaking, without prejudice to the action that may be taken under any other law for the time being in force, the said Unit shall be liable for penal action under the provisions of the Foreign Trade (Development and Regulation) Act, 1992.
