M/s Astra Specialty Compounds India Pvt Ltd ., Dahej SEZ. Request to Include " Manufacturing Services" in existing LoA.

M/s Astra Specialty Compounds India Pvt Ltd was issued Letter of Approval dated 06.02.2013 as amended from time to time, for setting up of a unit in Dahej SEZ to manufacture and export of items under various HS Codes falling under chapter 32, 39 & 85. The unit had started their commercial production from 01.10.2017.

M/s. Astra Specialty Compounds India Pvt Ltd, vide their letter dated 01.10.2024 has requested to Include "Manufacturing Services" in the existing LoA as per SEZ Rule 18 (6).

Rule 18(6) provides that: -

*"Units may also be setup for providing services or manufacturing services to Overseas Entities subject to following conditions, namely: -*

*(a)Capital goods, raw materials including consumables sub-assemblies, components, semi-finished goods shall be supplied by the Overseas Entity free of cost;*



(b)Capital goods for setting up such facilities may also be supplied on loan or lease basis, provided the notional value of such capital goods shall be taken into account for calculation of Net Foreign Exchange Earnings under rule 53;

(c)finished goods shall be exported out of the country or transferred to the Customs Bonded Warehouse to be maintained by the Overseas entity: Provided that any supplies of finished goods shall be as per the instructions of the Overseas entity;

(d)the Unit shall receive the consideration for its manufacturing services in convertible foreign exchange directly from the said overseas entity;

(e)in case the said manufacturing facility is used by the Unit for carrying out production on its own account, separate accounts shall be maintained for the manufacturing and service activity.

Explanation. - "Overseas Entity" means a non-resident or a person of foreign origin and includes a company not incorporated in India."

The firm vide letter dated 21.02.2025 has submitted an agreement for contract manufacturing executed between M/s Astra Specialty Compounds India Pvt Ltd and M/s Astra Polymers Jebel Ali Branch, UAE and the manner of procurement/supply of Capital goods and raw materials.

Hence, the case is placed before the Approval Committee for consideration and suitable decision.

None of the Directors or Representatives of the firm appeared before the committee. In past so many letters were written to the firm for non-implementation of the project which were not replied by the firm. The Committee had decided to cancel the LoA of the firm after obtaining no dues reports from the SO, Dahej SEZ and the Developer, Dahej SEZ Ltd. This office vide letter dated 04.07.2018 had requested the firm to submit indemnity bond and no dues from the SO, Dahej SEZ and Developer,

			Dahej SEZ Ltd. The SO, Dahej SEZ and Developer, Dahej SEZ Ltd has submitted no dues reports to this office.
2	M/s Fernas Construction India Pvt Ltd	25.07.2011	LoA of the firm got Expired on 05.12.2021. This office vide letter dated 06.02.2025 had requested the firm to submit the reasons for not applying for renewal of LoA and submit the reply within 15 days. But till date no communication is received from the firm.
3	M/s Agro Life Sciences Corporation	22.09.2021	LoA of the firm got Expired on 22.09.2022. This office vide letter dated 06.02.2025 had requested the firm to submit the reasons for not applying for extension of LoA and was given opportunity of personal hearing before the Development Commissioner, Dahej SEZ. The firm was requested to submit the reply within 15 days. But till date no communication is received from the firm.
4	M/s Fame Biofuels Private Limited	22.06.2022	LoA of the firm got Expired on 21.06.2023. This office vide letter dated 07.08.2024 had requested the firm to inform the current status of the project. But till date no communication is received from the firm.
