Request for granting permission for laying express water supply pipeline in Dahej SEZ Part-1 (from underground sump/ESR at SEZ Part-1 to plot premises of M/s. Vidhi Specialty Food Ingredients Limited)

M/s. Vidhi Specialty Food Ingredients Limited was issued LOA on 30.08.2019, as amended from time to time, for manufacture and export items under chapter 32 of ITS (HS) and started commercial production from 10.05.2023.

M/s. Vidhi Specialty Food Ingredients Limited vide their letter dated 04.07.2023 has submitted ROU approval letter of Dahej SEZ Ltd along with Route Map. The applicant vide their email dated 06.07.2023 has also submitted Chartered Engineer certificate to this office and requested to grant them permission to start the work of laying of water pipeline as the monsoon season is about to start in Dahej and it shall be impossible to carry out work of laying the pipeline in the rainy season.

The Senior Development Commissioner, Dahej SEZ had granted approval on the file and permission letter dated 07.07.2023 issued to M/s. Vidhi Specialty Food Ingredients Limited.



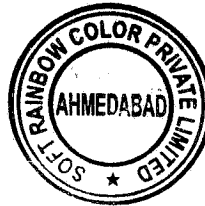

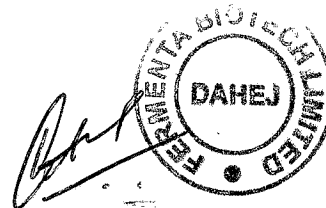
