

The proposal of M/s. Steamhouse India Limited, is for setting up a new unit in Dahej-SEZ. They have import of capital goods NIL for the proposed project. FOB value of exports for the 5 years period is projected as Rs. 2435.00 Cr with NFE of Rs. 974.00 Cr. The Developer (Dahej SEZ) has agreed in principle approval for allotment of plot of about 20,000 Sq. Mtrs. in the processing zone of Dahej SEZ for the proposed project in Dahej SEZ for setting up of unit.

In view of the above, the proposal for setting up of the unit is placed before Unit Approval Committee for consideration, and personal interview of the Director. The same is recommended for approval in terms of Rule 18 of the SEZ Rules, 2006.

Application for laying separate dedicated effluent Sea disposal pipeline for 6 MLD design capacity from OPAL premises to Deep Sea in Dahej.

M/s. ONGC Petro additions Ltd were approved LoA vide letter dated 17.10.2007 for setting up of new unit in Dahej SEZ. They were allotted plot no. Z/1 & Z/83 and started commercial production from 31.08.2015.

M/s. ONGC Petro additions Ltd vide their letter no. OPAL/DHJ/PRJ/Deep Sea Line/2022-23 dated 27.05.2022 requested for laying separate dedicated effluent Sea disposal pipeline for 6 MLD design capacity from OPAL premises to Deep Sea in Dahej.

M/s. ONGC Petro additions Ltd vide their letter dated 27.05.2022 informed that the waste water will be treated and discharge only after matching the discharge norms. Further, a Hydrodynamic and water quality modeling study was conducted for selection of a suitable location for achieving required dilution and diffusion. There will not be any impact on the marine eco-system due to the treated waste water discharge pipeline.

M/s Dahej SEZ Limited, a Developer of Dahej SEZ vide their letter dated 21.01.2020 issued in principal approval to M/s ONGC Petro additions Ltd for offering land on RoU subject to certain conditions including M/s ONGC Petro additions Ltd has to obtain permission for DC,SEZ/BoA for laying separate dedicated effluent Sea disposal pipeline for 6 MLD design capacity from OPAL premises to Deep Sea in Dahej.

The applicant unit submitted Route Map for the above said pipeline. The applicant unit has also submitted Chartered Engineers Certificate dated 11.03.2022. The total length of pipeline in SEZ area is 7134m (6000m-Opal's existing corridor + 1134m new Rou) The total cost of the said pipeline is 23.86 Cr.

The proposal of M/s. ONGC Petro additions Ltd granting permission for laying separate dedicated effluent Sea disposal pipeline for 6 MLD design capacity from OPAL premises to Deep Sea in Dahej is recommended to the Unit Approval Committee Meeting for consideration.

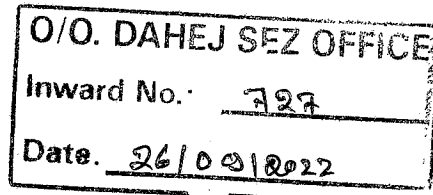

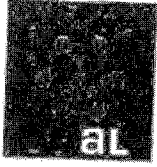

OPaL is a joint venture company promoted by ONGC and co-promoted by GAIL and GSPL. It is the single largest Petrochemical complex in India. It is located in Dahej Economic Zone (SEZ-1) and spread in 5.08 sq. km.

With reference to the above-mentioned subject, we would like to bring to your kind notice that OPaL intends to lay an independent treated waste water disposal pipeline from our ECTS plant within OPaL premises to deep sea Dahej.



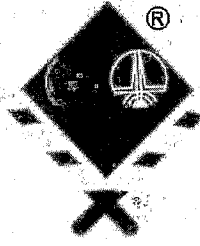

With reference to the above subject, In Principle Approval is herewith issued to M/s ONGC Petro additions Limited (OPaL) for offering land on RoU subject to following conditions:

1. M/s. OPaL is required to make formal application (Copy Enclosed) to DSL for RoU land alongwith application fees of Rs. 50,000/- (Nonrefundable) plus Rs. 9,000/- as GST..
2. M/s. OPAL has to obtain permission from Government of India / Development Commissioner to lay pipeline in Dahej SEZ Area.
3. M/s.OPAL has to submit the approval letter from GPCB / MOEF & GIDC to lay dedicated pipeline in deep sea before execution of agreement with DSL.
4. Before starting the work at site, M/s.OPAL has to execute ROU agreement with DSL.. Before starting the work at site, a trial pit is to be made to know the exact location of existing underground services within SEZ area. M/s. OPAL has to take care for the existing services within SEZ area. Trial pit must be done manually only. Trial pit shall be done in supervision of concern authority to avoid any damage to existing services.

During execution, if for any reason route of pipeline required to be changed, the alignment of pipeline will have to be modified accordingly.

7. M/s.OPAL. has to cross the existing/proposed services/ Roads/ Approach to unit on receipt of approval from concern authority and as per the methodology suggested by concern authority/DSL and cost for the same shall be borne by M/s. OPAL. DSL will not take any responsibility to obtain permission from concern authority for crossing of existing services. M/s.OPAL. has to complete the all formalities with concern authority for the same.
8. All crossings shall be done as per the approval granted by concern authority/ DSL.

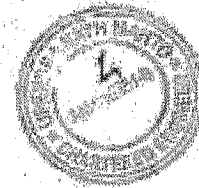

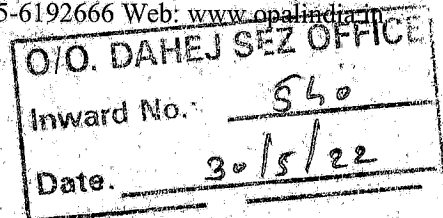

Further, a Hydrodynamic and water quality modelling study was conducted for selection of a suitable location for achieving required dilution and diffusion. The modelling output at the selected outfall location highlights maximum dilution at SPHHW – 1096 times and SPLW – 868 times for 250 mg/l COD. Maximum Zone of influence during SPFLD condition is 120 m (for COD) from the disposal point. Hence, there will not be any impact on the marine eco-system due to the treated waste water discharge pipeline.
2.	You are also requested to submit the Approval/NoC for effluent Sea disposal pipeline from GPCB and GIDC and submit the Chartered Engineering Certificate and Quantum of effluent to be discharge.
