Subject: - Implementation of ICEGATE at non-IT/ITES SEZs - extension of continuation of SEZ Online

With reference to the above mentioned subject, it is to inform that the extension for filing of documents on SEZ Online (NSDL now NDML) had been extended only upto 17th February, 2025 as a last grace period.

2. However, it has been observed that there are few SEZ Units in Dahej SEZ which have not yet even registered on the ICEGATE, despite several extensions being granted in this regard. It is to re-iterate that post 17th February, 2025, no further extension shall be granted for filing of export Shipping Bills and import Bills of Entry on NSDL SEZ Online. Hence with effect from 18th February, 2025, all export Shipping Bills and import Bills of Entry shall mandatorily be required to be filed on ICEGATE only.
3. As the last deadline of on-boarding on ICEGATE is approaching, it is again directed to onboard all the units onto the ICEGATE system at the earliest and file all documents only on ICEGATE to ensure seamless, smooth and complete transition to ICEGATE and to avoid any last-minute hassles.
4. In case of any disruption of import/export processes due to non-compliance with the said directions, the units themselves will be responsible. In case of any issues in registration process, the same may be communicated to this office/ICEGATE helpdesk on an urgent basis.
5. This is issued with the approval of the Development Commissioner, Dahej SEZ.
