Application for setting up unit in Dahej SEZ

PAN No.: AADCF1153D

Shri Darpan Shah and Shri Rishi Parikh, Director of Applicant Company appeared before the committee through WEBEX video conference and explained their proposal in detail for setting up unit in Dahej SEZ.

- (i) The proposal is for manufacture and export of Refined Glycerine HSN 29054500 & Methyl Ester or Acid Oil Methyl Ester (AOME) or Palm Oil Mill Effluent Methyl Ester (POMEME) HSN 38260000. Total cost of project is Rs.25.00 Crores and the project will generate employment for 45 persons.
- (ii) Total export for five years is projected at Rs. 198744.00 Lakhs with outgo of Rs. 147560.00 Lakhs, resulting in Net Foreign Exchange earnings of Rs. 51184.00 Lakhs in five years.

Applicant unit vide their email dated 14.06.2022 submitted the list of Raw Materials i.e. 1) Fluid, Mixed Inedible oil HSN 15180039 2) RBD Palm Stearin HSN 15119030 3) Acid Oil HSN 38231900 4) Palm mill oil effluent (POME) HSN 38231900 5) Methanol HSN 29051100 6) KOH HSN 28152000 7) NaOH HSN 28151110 8) Sodium Methoxide HSN 28151190 9) Hydrochloric Acid HSN 28061000 10) Crude Glycerine HSN 15200000 and they also undertake and confirm that products to be imported/procured do not fall under any restricted or prohibited category as per the Foreign Trade Policy. In future, if any product is added to the restricted or prohibited category will take the required approval from the Development Commissioner' office or the Board of Approval. Committee has raised the query regarding restriction of export of Methyl Ester or Acid Oil Methyl Ester (AOME) or Palm Oil Mill Effluent Methyl Ester (POMEME). The director of the unit has submitted the details and relevant Trade Notice No. 44/2018-19 dated 31.01.2019.

1. Wherein export of biofuels have been kept under restricted category and export is permitted under license only for non fuel purpose. This would imply that while export license would be granted for non-fuel purposes, no limerence would be granted for fuel purposes.

2. Subsequently, representation / application have been received from various exporters operating from special economic zone (SEZ) or EOU. It has been informed that the SEZ units have been granted LoA for export and bio fuels and EOU units have EPCG obligations to fulfil. Para 6.01 of foreign trade policy which deals with export from EOU and rule 26 of SEZ Rules, 2006 for SEZ units have been cited by the industry.

3. Considering the hardship faced by the trade community and the fact that production of bio-fuels in EOU/SEZ would be from imported feedstock, therefore, it would not impact upon the domestic production/consumption. Hence, the restriction as applicable to DTA may not be extended to EOU/SEZ.

The committee after detailed discussion unanimously approved the proposal subject to compliance of SEZ Act, 2005 and SEZ Rules, 2006 with the all other statutory Rules and Regulations of GPCB, MoEF etc.
