

Minutes of 111<sup>th</sup> meeting of the Approval Committee for Dahej Special Economic Zone held on Wednesday, 07.06.2023 at 12:00 Hrs through Video Conferencing under the Chairpersonship of Shri Vijay Kumar, ITS, Senior Development Commissioner, Dahej SEZ.

**B. Ratification of the Minutes of last meeting of the Approval Committee.**

**Item No. 111.03.01 M/s. C S Specialty Chemicals Pvt. Ltd., Plot No. Z/81 & 82 Application for change of the product ITC (HS) code in existing LoA.**

Shri Sandip Zaveri, Director from M/s C S Specialty Chemicals Pvt. Ltd., Plot No. Z/81 & 82 appeared before the Committee through WEBEX video conference and explained their request.

M/s C S Specialty Chemicals Pvt. Ltd., vide their letter dated 17.05.2023 requested for change of the product ITC (HS) code in LoA. The unit have been manufacturing and exporting the product "DONOR A- ETHYL-2-ETHOXY ETHYL CARBONATE to Japan and their Japanese customer has requested to classify the said product under ITC (HS) Code 29209000, as according to them, HS Code 29209000 is appropriate code for this item. The details of the said product and ITC (HS) are as under:-

The Approval Committee after detailed discussion unanimously approved the request for change of the ITC (HS) in existing Letter of Approval. The approval is further subject to compliance of SEZ Act 2005, SEZ Rules 2006 and all other relevant Rules and Regulations. All other terms and conditions mentioned in the Letter of Approval shall remain unaltered.

**M/s. Oil and Natural Gas Corporation Ltd. C2-C3  
Request of M/s. Oil and Natural Gas Corporation Ltd.,  
C2-C3 Plant for seeking In-Principle approval for exit  
cum de-notification from Dahej-SEZ.**

Shri P.L.Thakur, GM (P) and Shri Devender K Batish, GM (F&A) from M/s Oil and Natural Gas Corporation Ltd. C2-C3 Plant appeared before the Committee through WEBEX video conference and explained their request.


The Unit Approval Committee discussed the request of M/s Oil and Natural Gas Corporation Ltd., C2-C3 Plant, for in-principal approval for exit from Dahej SEZ in detail and deliberated that the proposal of in-principal exit from SEZ falls under the Rule 74 of SEZ Rules and de-notification of the entire land with plant and machinery.

The present proposal of M/s Oil and Natural Gas Corporation Ltd., C2-C3 Plant, with regard to exit from SEZ is not fully covered under Rule 74 of SEZ Rules, since the proposal is to move out from the SEZ along with land and other fixed assets which have been created and operational since 2015. Further, the de-notification of land occupied by the unit comes under the purview of Board of Approval. In view of this, the request of de-notification falls under Rule 6A (iii) of SEZ Rule, 2006 where it is mandatory that the Developer submits application in Form C5 for decrease in area to concerned Development Commissioner, as specified in Annexure III and check list as per Instruction no.102 of F.1/5/2016-SEZ dated 10.11.2019. So, in this matter, proposal for final approval of exit will be considered only on receipt of approval of partial de-notification of land from BoA, MoCI, New Delhi. Accordingly, UAC directed the unit that they may co-ordinate with the Developer, Dahej SEZ Ltd. and send the complete proposal with all compliance as per said circular of de-notification to Development Commissioner, Dahej SEZ to forward the proposal to Board of Approval, MoCI, New Delhi.

The UAC considered the request of in-principal approval of the unit for exit from Dahej SEZ and the same is approved by the Committee in terms of provisions of Rule 74 of SEZ Rules, 2006.

However, the unit is still under Dahej SEZ and the proposal for approval of final exit will be considered subject to approval of de-notification from Board of Approval, MoCI, New Delhi. As per Rule 74(2) (iii) the unit shall continue to be treated as unit within the SEZ till the date of final exit. The unit shall also make compliance with all the conditions as stipulated vide LoA dated 06.03.2007.

The calculation of duty due upto June-2022 as per sheet attached with the Agenda is provisionally calculated. All duty, taxes and liabilities which unit is liable to pay may be calculated and payment thereof shall be made on or before the final exit by them. In this regard, unit has also submitted the undertaking in Form L.
