## 27.3 FRESH CASES: -

#### 27.3.1 M/s. Survival Technologies Private Limited.

Shri Prashant Ruia, Director and Shri Chirag Patel, DGM from M/s. Survival Technologies Private Limited appeared before the Approval Committee for interview and put forth the following points.

- A presentation was shown of M/s. Survival Technologies Private Limited showing their manufacturing range of products based on wide variety of resins, reinforcements, fillers and additives.
- Company intends to produce Fine & Specialty Chemicals with annual capacity of 1200 MT at the Dahej SEZ Unit.
- Total cost of the project would be ₹ 3500 Lakhs and total employment would be 300 persons.
- Total FOB Value of export would be ₹ 46,300.00 Lakhs in five years period and NFE would be ₹ 11778.00 Lakhs for that period.
- It was confirmed that there is no case against the company of Central Excise, Customs and Income-tax Department.
- It was confirmed that there was no toxic, radioactive or hazardous gas involved in the project. Effluents generated will be within the standard limits and will be treated inside the plant.

### Observations/Clarifications of the Committee:

After detailed deliberations, the proposal was approved, subject to standard terms & conditions and undertaking by the unit that the raw materials used will not be any Specialty Chemicals, Organisms, Materials and Equipments Technology (SCOMET)/ODS items.

#### 27.3.2 M/s. Galaxy Surfactants Ltd.

Shri Vaijanath Kulkarni, Head-NPT, Manufacturing & Shri Babu Iyer, Head-Corporate of M/s. Galaxy Surfactants Ltd. appeared before the Approval Committee for interview and put forth the following points.

 A presentation was shown of M/s. Galaxy Surfactants Ltd. showing their manufacturing range of products based on Mill Liners, Pump Parts, Chute & Hooper Liners.

- Company plans to establish activities in two phases in Dahej SEZ. Phase-I will be completed in 1½ years and Phase-II will be completed by produce Organic Surface Active Agents at the Dahej SEZ Unit.
- Total cost of the project would be ₹ 37500.00 Lakhs and total employment would be 415 persons.
- Total FOB Value of export would be ₹ 229199.00 Lakhs in five years period and NFE would be ₹ 69089.00 Lakhs during the period.
- There are some cases of Central Excise, Customs and Income-tax Department against
  the company and are pending at various stages. Shri Iyer submitted that the cases
  were mostly matters of interpretation and the company as well as any of the directors
  of the company were not proceeded against or debarred from getting any
  licence/Letter of Permission. Separate undertaking was given by the company for the
  same.
- It was confirmed that there was no toxic, radioactive or hazardous gas involved in the project. Effluents generated will be within the standard limits and will be treated inside the plant.

# Observations/Clarifications of the Committee:

After detailed deliberations, the proposal was approved, subject to standard terms & conditions and undertaking by the unit that the raw materials used will not be any SCOMET /ODS items. Further, the unit was informed regarding scarcity of water in the Dahej SEZ. Unit agreed to curtail their water requirement.

#### 27.3.3 M/s. Euclid Constructions Ltd.

Shri Suresh Kumar Authorised Representative of M/s. Euclid Constructions Ltd. appeared before the Approval Committee for interview and put forth the following points.

- Company intends to provide Pre Construction Services, Pre Project Development, Construction Management, Facility Management services at the Dahej SEZ Unit.
- Total cost of the project would be` 1483 Lakhs and total employment would be 100 persons.
- NFE calculations were not provided by the company.
- There were some queries against the applicant, raised by the DC office and the same were not replied by the company so far.

# Observations/Clarifications of the Committee:

After detailed deliberation the proposal was deferred to the next meeting of the Approval Committee as the project of the company could not be judged in absence of NFE calculations and the company was directed to reply the queries and submit NFE calculations urgently.

#### 27.4 DEFERRED CASES: -

#### 27.4.1 M/S.VIJAY TANKS & VESSELS LTD.

Shri A V Jayaram of M/s.Vijay Tanks & Vessels Ltd. attended the meeting. Unit has requested for broad-banding of authorized operations in Dahej SEZ. The unit requested to grant approval to send components in CKD and SKD conditions to carry out the final assembly at the project site.

It was intimated to the unit that separate permission is not required as it is already covered in the existing LOA under authorized operations.

# 27.4.2 M/S.ROXUL-ROCKWOOL INSULATION INDIA LTD.

The proposal of the unit was approved subject to the condition that for providing services to their group company outside SEZ, the unit would get registered with the Service Tax Authority. For providing such services outside SEZ, the unit has to pay the Service tax as per prevailing rate. It was decided that DC office would intimate all the service providers to get registered with the Service Tax Authority.

It was informed by the unit that:

 LOA was issued to the unit in the name of M/s. Indofil Chemicals Company on 03.03.2008, which was a division of M/s. Indofil Organics Industries Ltd. The legal entity, however, is M/s. Indofil Organics Industries Ltd. only and the certificate of Registrar of Companies also shows the same name.

- M/s. Indofil Industries Ltd. Dahej SEZ Unit will have distinct identity with separate books of accounts, in accordance with the provision of Rule 19(7) of the SEZ Rules, 2006.
- All the applicable taxes, duties etc. would be paid for all transactions between Dahej SEZ unit and other units of M/s. Indofil Industries Ltd.
- 4. The board resolution in this regard would be submitted by the unit within a fortnight.
- The details of transactions between M/s. Indofil Chemicals Company (i.e. unit within Dahej SEZ) and M/s. Indofil Organic Ltd., done prior to this change may be submitted by the unit for scrutiny of applicable taxes to the office of Commissioner of Central Excise, Vadodara-II.

#### 27.5.2 M/S. RALLIS INDIA LTD.

Shri Y J Rao, Head Technology & Business Development attended the meeting. He requested for enhancement of production manufacturing quantities and also to add some new products.
