M/s Dahej SEZ Limited: -


Application for approval of additional list of goods for Authorized Operations.

Shri Niraj Shah, Manager Infra from M/s Dahej SEZ Limited had appeared before the committee through WEBEX video conference and explained their request.

M/s. Dahej SEZ Ltd., Gandhinagar a Developer of Multi Product Special Economic Zone had requested vide their letter no. DSL/2024-25/35 dated 23.10.2024 for additional list of goods in Annexure-VI, Annexure (A) and Annexure (B) duly certified by the Chartered Engineer for carrying out Authorized Operations in Dahej SEZ to claim various exemption and benefits under the SEZ Act, 2005 and SEZ Rules, 2006.

The committee after detailed discussion unanimously approved the additional list of goods except approval of Solar power plant and gardening equipments subject to compliance of the SEZ Act, 2005 and SEZ Rules, 2006 and all other relevant Rules and Regulations.
