Shri Dipak Kantariya - Director of Applicant Company appeared before the committee through WEBEX video conference and explained their proposal in detail for setting up unit in Dahej SEZ.

- I. The proposal is for manufacture and export of Calcium Chloride. Total cost of project is Rs. 16,50,00,000 and the project will generate employment for 50 persons.
- II. Total export for five years is projected at Rs. 15000.00 Lakhs with outgo of NIL Lakhs resulting in Net Foreign Exchange earnings of Rs. 15000.00 Lakhs in five years.

The committee after detailed discussion unanimously **approved** the proposal subject to compliance of SEZ Act, 2005 and SEZ Rules, 2006 with the all other statutory Rules and Regulations of GPCB, MoEF etc.
